

STUDENT IN RESIDENCE

A student-in-residence placement at the Hunter Hub for Entrepreneurial Thinking takes place as part of Experience Ventures during the fall 2021 semester. As a student-in-residence, eligible students have the opportunity to take a deep dive on a topic that interests them through the lens of entrepreneurial thinking while engaging with multiple ventures within the community.

Experience Ventures creates paid entrepreneurial thinking placements for college and university students with innovative companies in Canada. Our goal is to inspire your creativity, resiliency and future vision – so you can seize your future with the right skill set.

THE OPPORTUNITY

The student-in-residence placement is a unique experience that will provide the successful candidate an opportunity to work with a University of Calgary faculty member and local ventures to explore a specific theme. Our goal is to inspire your creativity, resiliency and future vision – so you can seize your future with the right skill set.

Through an 80 hour placement, under the guidance of Dr. Alice de Koning, the student will have the opportunity to work with 3-5 ventures. The goal will be to meet with leaders of the ventures, learn more about the challenges and successes they face, and help create videos or articles sharing their stories.

This is ideal for students interested in:

- Social enterprise: How do organizations serve social priorities while maintaining financial viability?

There is one student-in-residence opportunity in this category open at this time.

ELIGIBILITY REQUIREMENTS

Any student from any discipline and faculty registered at the University of Calgary who is:

- A Canadian citizen, permanent resident, or person on whom refugee protection has been conferred under the Immigration and Refugee Protection Act.
- Legally entitled to work in Canada in accordance with relevant provincial or territorial legislation and regulations.
- Enrolled in any full- or part-time program of post-secondary study.

HOW DOES IT WORK?

- Apply through the [Hunter Hub website](#).
- After acceptance, the student completes an onboarding process before participating in the entrepreneurial thinking opportunity.
- The student meets with Dr. Alice de Koning to set up a schedule and timelines for deliverables.
- After completing the opportunity, the student completes an evaluation.
- Each student will be paid \$825 for their time.
