

## Anticipated Increases to Tuition Fees and Mandatory Non-instructional Fees for the Period 2023-24 to 2026-27

---

### Purpose

This document provides the proposed percentage increases to tuition and general fees at the University of Calgary for the 2023-24 academic year, and projected increases for the years 2024-25, 2025-26, and 2026-27. The projected increases are estimates and are subject to change.

### Anticipated Increases

For the period 2023-24 to 2026-27, the University of Calgary is projecting to increase domestic tuition by the CPI average across the institution with no program increasing by more than 10.0%. For planning purposes, a CPI of 2.4% (AB's Economic Outlook assumption) has been used for 2024-25 and 2.0% for 2025-26 and 2026-27 calculations until the confirmed CPI rates are available.

For 2023-24, international tuition for most undergraduate and course-based Master's programs is proposed to increase by 10.0%, and for thesis-based programs by 2.0%. Guaranteed maximum\* increases for future years are proposed for most undergraduate and course-based Master's programs at 10.0%, and for thesis-based programs at 2.0%.

The following tables include:

1. **General Fees:** These fees apply to undergraduate and graduate students. Proposed general fee increases for 2023-24 must be reviewed and approved by the Board of Governors before coming into effect. Projected fee increases for future years (2024-25, 2025-26, and 2026-27) are calculated using the CPI placeholder amount (2.4% & 2.0%) and are an estimate only.
2. **Domestic Tuition (Undergraduate and Graduate):** Proposed tuition increases for 2023-24 must be reviewed and approved by the Board of Governors before coming into effect. Projected tuition increases for future years (2024-25, 2025-26, and 2026-27) are calculated using the CPI placeholder amount (2.4% & 2.0%) and are an estimate only.
3. **International Tuition (Undergraduate and Graduate):** Proposed tuition increases for 2023-24 must be reviewed and approved by the Board of Governors before coming into effect. If approved by the Board, projected increases for future years (2024-25, 2025-26, and 2026-27) will be the maximum allowable\* for students beginning their programs in the 2023-24 academic year.

\*All international students at the university are provided with a maximum tuition guarantee in their offer of admission. As per the Tuition Fee Regulation, proposed and projected increases cannot exceed those amounts for continuing students.
