The Chair called the meeting to order at 2:01 p.m. and confirmed quorum.

1. Approval of the Agenda

2. <u>Remarks of the Chair and Vice-Chair</u>

The Chair included the following in his remarks:

- The members of the GFC Executive Committee (the Committee) were welcomed to this first meeting of the 2024-2025 meeting year
- This is an important committee for GFC and University governance, as the Committee engages in critical discussions and conducting business on behalf of or recommending business to the GFC, and members are appreciated for their service

- Meetings of the U15 institutions have recently been held, and the local issues the Presidents are facing are interesting to hear about. Regardless of the outcome of the next federal election, the U15 institutions are well positioned and will with the government, and representatives are continuing advocacy efforts in Ottawa on the about the importance of postsecondary institutions and to position this sector in a good light and to be top of mind for elected officials.
- The Universities Canada Board of Directors is composed in part of 12 university Presidents. The University of Calgary President's term on this board is ending.
- Marc Miller, federal Minister of Immigration, Refugees and Citizenship, is being asked to improve the student visas process
- Rajan Sawhney, Alberta Minister of Advanced Education, will be providing an update to the province's postsecondary Presidents and Board Chairs tomorrow about the Provincial Priorities Act, 2024 (Bill 18). There remains hope that postsecondary institutions will be exempted from the requirement to obtain prior approval from the Alberta government before entering into or renewing agreements with the federal government (such as for research grants).

The Vice-Chair included the following in her remarks:

- It has been an exciting summer of settling into the Provost and Vice-President (Academic) role and getting to know the University's leaders and their portfolios
- A special meeting of the GFC was held on July 10, 2024, and the Vice-Chair chaired this meeting
- Orientation for graduate students is being held today, orientation for new academic staff members is being held tomorrow, and orientation for undergraduate students will be held on Thursday and Friday this week
- The University's recruitment team hosted guidance counsellors from all over the world during Stampede in July. This initiative was successful and applauded, and these persons will be ambassadors for the University around the world.
- The Registrar's Office has launched a new classroom search tool, and members are encouraged to share this with others
- Aleem Bharwani, Academic Director of the UCalgary Pluralism Initiative, will be spearheading a series of campus dialogue sessions aiming to bring the University community back together through unpacking recent experiences (i.e., the impacts of geopolitical issues, the encampment) in a constructive way to co-create solutions

3. <u>Committee Orientation and Nominations Guidelines</u>

The *General Faculties Council Executive Committee Nomination and Appointment Guide* was circulated as a table document to support Committee members with their work. It was reported that this document will be made available on the Committee's D2L site, in the August 28, 2024 meeting folder and in the Resources section.

The University Secretary and Governance Coordinator then gave a presentation orienting the members to the work of the Committee, including:

- An overview of the University's governance structure; the membership, role, and responsibilities of the Committee and the expectations of members; educational resources available to members; and the supports provided to the Committee by the University Secretariat
- Explanation of the Committee's appointments and GFC elections nominations processes

• Encouragement to attend the full GFC and GFC Standing Committees Members Orientation session being offered on Thursday, September 12, 2024

Discussion included expressions of appreciation for the *Nomination and Appointment Guide*, and the University Secretary acknowledged Jacqueline Jenkins, Committee member, Joule Bergerson, past Committee member, and the Vice-Provost (Equity, Diversity and Inclusion) who had helped to produce this.

In response to a question, it was indicated that the University Secretariat can help units with governance work and that interested persons may attend the annual GFC and GFC Standing Committees Members Orientation session in order to learn about University governance and meeting practices.

4. Naming of the Academic Co-Chair of the Academic Program Subcommittee
