Official Course Description

Focuses on field data collection and laboratory and computational analysis techniques practiced by physical geographers. Students will conduct an integrated analysis of a local landscape, including site selection, sample collection, lab analysis, and data assimilation and interpretation for report writing. Approximately one-half of the course is taught outdoors.

Course Objectives

To provide experience in undertaking a field research project from beginning to end including, research design, identification and use of appropriate methodology, data collection and analysis, and information synthesis and presentation. These objectives will be facilitated by introducing students to various methodologies used to study the physical geography of the region. Through a series of on-site lectures, seminars and field excursions students learn how to undertake an investigative research project in a tropic environment.

The focus of the course this term will be on the geography of Barbados. Students will gain hands-on experience in undertaking field studies across the island ranging from the island's geomorphology to the current day-to-day interaction between the island's environment and society.

The specific topics to be researched by the students will be determined in consultation with the instructor.
