## **Official Course Description**

Field research and reconnaissance survey techniques. Individual and group travel-study combined with formal instruction and seminars.

### **Course Objectives**

This course focuses on the physical/environmental context of select locations in Thailand, Singapore, and Indonesia. The tremendous variety of physical landscapes included in this itinerary provides spatial settings for diverse studies and comparative analyses. Topics will include climate, climate, regional biogeography, mountain building and degradation, soils of the region, natural resources, fluvial geomorphology, karstic topography, shore line geomorphology, natural hazards and disasters. The course focuses on recourses, environmental problems relating to both natural and human landscapes. This itinerary provides spatial settings for diverse studies and comparative analyses. Topics will include impacts of climate change, land degradation, deforestation, human's current and historical effects on landscapes, water issues, power generation, geothermal and hydrocarbon recourses, natural environmental disturbances, air pollution, and an examination of different agricultural practices. Topics will include the construction of Dams; coal fire power; the impacts of climate change on tropical and subtropical ecosystems; the management of Dams and other river systems; specific environmental problems that have emerged from development; soil management, degradation, and agricultural practices and environmental impacts of tourism development and expansion throughout the region. This course also focuses on the urban environment. Within cities, the main objectives are to provide a geological, climatologic, and hydrologic setting within which the cities exist, to illustrate how historical urbanization has modified this environment, to explore how the historical & contemporary urbanization impacted, and is impacting, vulnerability to climate change, and hazards posed by natural processes, and to assess the urban environment, population, resources, and greenspaces as a functioning ecosystem.

### **ARTIFICIAL INTELLIGENCE (AI)**

Students may use generative AI tools throughout in this course to enhance their learning within reason. **Students MAY NOT use AI for generating answers for assignments, assessments, field notes, project submissions or any other academic submissions for this course**. Students are responsible for citing and referencing all work generated by AI tools as outlined by the course instructor. Students must be accountable for their submissions. AI generated answers to assignments will be assigned a zero grade and may be referred to the Faculty of Arts for academic misconduct discipline.

### Freedom of Information and Protection of Privacy

Freedom of Information and Protection of Privacy (FOIP) legislation in Alberta regulates the return of term assessments. All assignments will be submitted on D2L in the format outlined in the term assignment.
