# **Description**

Further field exploration of cities on the cutting edge of sustainability and smart innovation, building from Urban Studies 494. Economic, political, and cultural aspects of sustainability and smart innovation are considered, focusing on urban form, mobility systems, social geography, and political processes. Theoretical and practical links between urban, municipal, and national policies, and global sustainability discourses are made.

#### **Course Objectives**

Economic, political, and cultural aspects of sustainability and technology will be considered with respect to urban form, social geography, and mobility systems. Theoretical and practical links between urban, municipal, and national policies, on the one hand, and global sustainability discourses, on the other, will be made. Students will be introduced to examples of sustainability initiatives and smart city technologies in planning exemplified by select cities and neighbourhoods. Best practices in subjects such as urban planning, transportation, energy systems, sanitation, recycling, residential and industrial design and many other social and political aspects of cities will be addressed.
